Cookies

The Site is developed using per-session "cookies" (pieces of data your browser stores in your computer's memory at Weyerhaeuser's request) to establish user sessions on our server. We use the cookies to carry information about usage from page to page through the Site. Weyerhaeuser does not use cookies to retrieve personal information about you from your computer. Most browsers are set up to accept cookies, but you can usually change your browser settings to refuse them.
