

For many people, an opportunity to camp is an important part of a quality hunting experience. To satisfy this request, Weyerhaeuser has developed a program that accommodates a wide range of camping preferences. Our program is founded upon three key principles: safety, aesthetics and compliance with all laws. Please read and follow all program guidelines to ensure that camping privileges remain available for your future enjoyment.

To designate a new campsite or to notify us of a pre-existing campsite that is <u>not</u> currently associated with your lease, please complete the request form at the end of this document and email it to your Lease Administrator. #### **<u>Camping Options</u>**. We offer you 2 options to camp – "No Trace" and "Designated" as summarized below:

*Important Note*	Weyerhaeuser conducts routine campsite audits to ensure compliance with all guidelines. Failure to accurately report campsite information (location, acreage & # of year-round structures) will result in penalties double the normal fee amounts and potential loss of future camping privileges. Likewise, any materials left on-site after NO-TRACE camping, will result in a penalty of double the per acre campsite fee and potential loss of camping privileges.		

\*<u>Club Community Structure</u> – To provide hunters a covered meeting shelter for added camaraderie, each club may erect one (1) structure of no greater than 400 square feet in size. This structure may have a roof and not more than 3 fixed exterior sides (walls) over a bare soil floor surface (no wooden flooring or concrete slabs allowed). This structure may be used for off-season equipment storage, but the 4<sup>th</sup> side must remain open at all times (no tarps). This community structure is expected to serve the <u>entire</u> hunting club/camp; thus only 1 structure per approved campsite is allowed.

**General Camping Guidelines.** Follow these guidelines for ALL camp types, "No Trace" and "Designated":

- Camper trailers / structures must be maintained in a safe and sanitary manner to comply with all federal, state and local laws, ordinances, restrictions, and regulations, including any regulatory measures related to sewage discharge.
- The campsite must be kept in an extremely neat condition. Debris must be removed at the end of each camping trip.
- Service and maintenance of motorized vehicles, ATV's or other equipment is **NOT** allowed on Weyerhaeuser land.
- Campfires are normally permitted, but are subject to ban during hazardous conditions that prevent safe use. Contain all campfires within a fire ring and fully extinguish all embers before leaving the campsite.
- Locate your camp away from the view of public roads, as this will greatly reduce the likelihood of any vandalism.



Once the "out of view" requirement is met, establish your camp as close to public access as possible. Locating a camp deep into your lease can negatively impact hunting, and it may not be readily accessible during wet-weather events without causing damage to woods roads. Remember, all "Designated Campsites" require advance approval from Weyerhaeuser before setup and use.

# "No Trace" Campsite Guidelines. In addition to general guidelines, "No Trace" campers should follow these rules:

- Overnight camping is allowed using camping trailers, RV's or tents.
- "No Trace" campers can set up a sign-in / sign-out board and deer hanging rack that remain on site year round. All other camping materials must leave the site at the end of each hunting trip
- "No Trace" campers may **NOT** erect a Club Community Structure or any other fixed structure of any kind.
- Camps should be located a safe distance away from any active logging or silviculture operation and away from the primary vehicular routes that serve these operations.

# **Designated Campsite Guidelines.** In addition to general guidelines, these rules apply to all "Designated" camps:

- Clubs who want to designate a NEW campsite must first submit the attached CAMPSITE REQUEST FORM. Clubs
  must receive explicit written approval from Weyerhaeuser <u>before</u> any new site is established. Once approved, you
  do <u>NOT</u> need to resubmit this form each year to continue camping.
- Campers/RVs may be left on site from August 1- May 31 for no charge. A \$200 fee will be assessed for each camper, RV or fixed structure that remains during the period June 1 thru July 31. The \$200 fee does not apply to a satisfactory Club Community Structure.
- Except for 1 Club Community Structure, construction of any new buildings or permanent structures (to include cabins, sleeping structures, porches, decks, concrete slabs, trailer / RV canopy and storage buildings) is <u>NOT</u> allowed.
   Explicit approval from Weyerhaeuser is required **before** adding any new Club Community Structure to a campsite.
- All vehicles (including camping trailers and RV's) must display current registration (tag) and exist in good running condition at all times.
- Shipping containers, construction trailers, school buses, mobile homes and panel vans are not allowed on Weyerhaeuser land at any time.
- Water service (drilling wells or connecting to public water utilities) is **NOT** permitted.
- We strongly recommend that clubs use portable generators to satisfy electricity needs. Any connection to an
  electrical utility service requires explicit, <u>advance</u> approval from Weyerhaeuser; requests that require a right-of-way
  (ROW) grant will <u>NOT</u> be considered.
- Weyerhaeuser may elect to cut and remove trees inside the designated campsite area at its sole discretion; in this event, the Lessee will be asked to move mobile structures to facilitate the harvest operation.
- <u>All campsites are subject to routine inspection and audit by Weyerhaeuser. Removal of any / all structures</u> and camping equipment will be required immediately if, in Weyerhaeuser's sole opinion, these items become dilapidated, represent a safety risk, are an eye sore or are found to be out of compliance with zoning codes.

### Special Guidance for Existing Designated Camps

- Many existing camps contain non-mobile structures and buildings constructed over time. These buildings are each subject to the \$200 annual fee because they remain on site year round.
- Effective immediately, further modification and additions to these existing structures is **NOT** allowed (porches, decks, rooms, etc). Likewise, no new non-mobile structures are permitted. Going forward, existing structures may remain, subject to Weyerhaeuser approval, only as long as they are <u>maintained</u> in a safe and neat condition and fully satisfy all current or future building codes and regulations. If any of these conditions are not met, the structure must be immediately removed from the campsite.

### **Special Guidance regarding Dog Kennels**

- Dogs may be kenneled on the property only during hunting season or training seasons <u>when the owner is in</u> <u>camp</u>. Clubs may <u>NOT</u> kennel dogs on Weyerhaeuser property year-round or leave dogs unattended.
- Dog kennels must be located within the designated camping area footprint, and will be subject to the \$200 yearround structure fee. Any new kennels may be built only with prior approval from Weyerhaeuser.
- Old kennels in poor condition must be removed from the property as a condition of your lease.

Clubs requesting a Designated Campsite <u>must</u> report their campsite location by providing GPS latitude/longitude coordinates *AND* by making a copy of your lease map and marking the campsite location with an X.
